## Public Art Opportunity: Sculpture on the Move

The Creative Communities Alliance (CCA) is a coalition of municipal and nonprofit organizations dedicated to the development of community arts in the St. Louis and surrounding Missouri region.

We are now accepting applications for the 2023 round of Sculpture on the Move where we will install approximately 20 sculptures for prominent display in outdoor, public areas around the region. These sculptures will be installed in the spring of 2023 for a period of two years, at which point artists can resubmit their work to be selected for another location within the regional display. Artists may submit multiple works and may have multiple works selected across the participating communities.

### Requirements:

Open to all artists living in the United States.

Each work must fit on a 4ft x 4ft concrete pad.

There is no limit to the number of sculptures submitted by an artist.

Artist agrees that work submitted is original work created by the artist.

**All work must be ready for installation upon delivery. Artist accepts responsibility for delivering and retrieving work on dates as agreed upon in the final contract.**

### Selection process:

Each municipality/community will select at least one sculpture from the pool of submissions. After the selection, a representative from that community will work directly with the artist to finalize the contract, payment schedule, as well as delivery and installation dates.

**Please note - your sculptures may be chosen by a variety of communities across the region. You are responsible for transporting your sculpture to the community that selects it. If this is an issue, please note it in your application.**

**Award:** The selected artists will be awarded \$1,000 per year for two years, for each sculpture selected, resulting in a total of \$2,000 per sculpture.
